**A BILL**

To reauthorize the HOME Investment Partnerships Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “HOME Investment  
5 Partnerships Reauthorization Act of 2020”.

6 **SEC. 2. REAUTHORIZATION OF HOME INVESTMENT PART-**  
7 **NERSHIPS PROGRAM.**

8 Section 205 of the Cranston-Gonzalez National Af-  
9 fordable Housing Act (42 U.S.C. 12724) is amended to  
10 read as follows:

1 **“SEC. 205. AUTHORIZATION OF APPROPRIATIONS.**

2 “There are authorized to be appropriated to carry out  
3 this title—

4 “(1) \$5,000,000,000 for fiscal year 2021;

5 “(2) \$5,250,000,000 for fiscal year 2022;

6 “(3) \$5,512,500,000 for fiscal year 2023;

7 “(4) \$5,788,125,000 for fiscal year 2024; and

8 “(5) \$6,077,531,250 for fiscal year 2025.”.

9 **SEC. 3. TECHNICAL CORRECTIONS.**

10 The Cranston-Gonzalez National Affordable Housing

2 paragraphs” and inserting “paragraphs”;

3 (3) in section 106 (42 U.S.C. 12706), by strik-  
4 ing “Stewart B. McKinney Homeless Assistance  
5 Act” and inserting “McKinney-Vento Homeless As-  
6 sistance Act”;

7 (4) in section 108(a)(1) (42 U.S.C.  
8 12708(a)(1)), by striking “section 105(b)(15)” and  
9 inserting “section 105(b)(18)”;

10 (5) in section 212 (42 U.S.C. 12742)—

11 (A) in subsection (a)—

12 (i) in paragraph (3)(A)(ii), by insert-  
13 ing “United States” before “Housing Act”;  
14 and

15 (ii) by redesignating paragraph (5) as  
16 paragraph (4); and

17 (B) in subsection (d)(5), by inserting  
18 “United States” before “Housing Act”;

19 (6) in section 215(a)(6)(B) (42 U.S.C.  
20 12745(a)(6)(B)), by striking “grand children” and  
21 inserting “grandchildren”;

22 (7) in section 217 (42 U.S.C. 12747)—

23 (A) in subsection (a)—

24 (i) by striking paragraph (3), as  
25 added by section 211(a)(2)(D) of the

1           Housing and Community Development Act  
2           of 1992 (Public Law 102–550; 106 Stat.  
3           3756); and

4                   (ii) by redesignating the remaining  
5           paragraph (3), as added by the matter  
6           under the heading “HOME INVESTMENT  
7           PARTNERSHIPS PROGRAM” under the head-  
8           ing “HOUSING PROGRAMS” in title II of  
9           the Departments of Veterans Affairs and  
10          Housing and Urban Development, and  
11          Independent Agencies Appropriations Act,  
12          1993 (Public Law 102–389; 106 Stat.  
13          1581) as paragraph (2); and

14          (B) in subsection (b)(1)—

15                   (i) in the first sentence of subpara-  
16          graph (A)—

17                           (I) by striking “in regulation”  
18                           and inserting “, by regulation,”; and

19                           (II) by striking “jurisdiction” the  
20                           first place that term appears and in-  
21                           serting “jurisdictions”; and

22                           (ii) in subparagraph (F), by striking  
23                           “Banking, Finance and Urban Affairs”  
24                           each place that term appears and inserting  
25                           “Financial Services”;

1           (8) in section 218(c)(3) (42 U.S.C.  
2           12748(c)(3)), by striking “section 224” and insert-  
3           ing “section 223”;

4           (9) in section 220(c) (42 U.S.C. 12750(c))—

5                 (A) in paragraph (3), by striking “and” at  
6           the end;

7                 (B) in paragraph (4), by striking the pe-  
8           riod at the end and inserting a semicolon; and

9                 (C) by redesignating paragraphs (6), (7),  
10           and (8) as paragraphs (5), (6), and (7), respec-  
11           tively;

12           (10) in section 225(d)(4)(B) (42 U.S.C.  
13           12755(d)(4)(B)), by striking “for” the first place  
14           that term appears; and

15           (11) in section 283 (42 U.S.C. 12833)—

16                 (A) in subsection (a), by striking “Bank-  
17           ing, Finance and Urban Affairs” and inserting  
18           “Financial Services”; and

19                 (B) in subsection (b), by striking “General  
20           Accounting Office” each place that term ap-  
21           pears and inserting “Government Account-  
22           ability Office”.
