FY2023 Community Project Funding for Nevada

Senator Rosen and Senator Cortez Masto requested funding for projects in their communities to be included in the FY2023 omnibus funding agreement. The funding awarded to Nevada projects is listed below by subcommittee.

Agriculture, Rural Development: (4 total)

City of Fallon – Fixed Based Operations Facility - \$825,000

City of Fallon's Fixed Based Operations Facility project request consists of the demolition and reconstruction of a new state of the art Fixed Base Operations Center (FBO) at the Fallon Municipal Airport (FLX).

Nevada Department of Agriculture – Wild Horse Management - \$500,000

Nevada Department of Agriculture's Wild Horse Management project request will implement a pilot study in cooperation with local partners to count and verify current feral/estray horses and develop long-term management solutions including establishing a formal horse adoption program, providing diversionary feeding to keep herds away from major cities and roadways, and erecting fencing in high traffic areas to complement private entity fencing efforts.

Storey County - Fire Station 71 - \$3,750,000

Storey County's Fire Station 71 project request will rebuild Storey County Fire Protection District Fire Station 71 located in Virginia City.

Storey County - Virginia City Fairgrounds - \$615,000

Storey County's Virginia City Fairgrounds project request will include installation of water and electricity to the County Fairgrounds facility, construction of ADA restrooms, paving and correct roads to the facility, and parking lot to improve public safety.

Commerce, Justice, and Science: (10 total)

City of Henderson - Dispatch Consoles - \$2,624,000

City of Henderson's Dispatch Consoles project request will fund dispatch consoles and radios for a new Henderson 9-1-1 Communications Center, the central Primary Safety Answering Point (PSAP) for police, medical, and fire responses.

<u>City of Henderson – Equipment for Eldorado Valley Regional Public Safety Training Facility -</u> \$2,049,000

City of Henderson's Eldorado Valley Training Facility Equipment project request will enhance the facility through the purchasing of equipment necessary to assemble a "training village," purchase an additional training simulator and computer equipment, and enhance the ability to train during hot summer months.

<u>City of Henderson – Mental Health Co-Responder Crisis Unit - \$2,955,000</u>

City of Henderson's Co-Responder Crisis Unit project request will provide funding to increase its ability to safely and effectively respond to people suffering from a behavioral health crisis through a Co-Responder Unit.

<u>City of North Las Vegas – Municipal Court Case Management System Upgrade - \$300,000</u> City of North Las Vegas' Municipal Court Case Management System Upgrade project request will upgrade case management to a paperless system, which will allow the court to work remotely, hold virtual hearings, send automated notifications, and offer a full suite of online dispute resolutions.

<u>City of North Las Vegas – Police Officer Wellness Program - \$145,000</u>

City of North Las Vegas' Officer Wellness project request will promote officers' physical health through increased exercise and retrofit spaces within the Department to serve officers' mental health needs.

<u>City of North Las Vegas – Police Department Technology Upgrade - \$100,000</u>

City of North Las Vegas' Police Department Technology Upgrade project request will upgrade its failing audio-visual equipment to more efficiently run police training and briefings.

<u>City of Reno Police Department – Forensics Software and Equipment - \$1,500,000</u>

City of Reno Police Department's Forensics Software and Equipment project will allow the Reno Police Department to purchase equipment and software to document crime scenes and conduct investigations through its new Forensics and Evidence Unit.

<u>Clark County – District Attorney's Office Case Management System – Criminal and Juvenile</u> Divisions - \$1,576,000

Clark County's Case Management project request will procure a cloud-based system for case tracking, document generation, document management, evidence management, subpoena generation, event driven workflow engine, extensive reporting, and electronic data exchange.

<u>Clark County - Public Defender Counseling Services to Reduce Recidivism Program - \$175,000</u> Clark County's Public Defender Counseling Program project request aims to reduce recidivism by providing counseling to clients of the Clark County Public Defender's Office.

Elko Sheriff's Department - Rapid DNA Testing Instrument - \$486,000

Elko Sheriff's Department's Rapid DNA Instrument project request will fund the purchase of a Rapid DNA instrument to help bolster law enforcement efficiency, improve community outcomes, and assist in easing the workload in Nevada's state crime lab.

Energy Water and Development: (5 total)

City of Caliente - Advanced Metering Infrastructure - \$148,000

The City of Caliente's Advanced Metering Infrastructure project request will modernize the city's aging electric metering system to enable remote meter reading, network problem identification and trouble-shooting, load profiling, energy audit, and partial load curtailment in place of load shedding.

City of Fallon – New River Feeders - \$879,835

Fallon's New River Feeders project request will install two additional circuits, known as the New River Feeders, to the recently constructed and commissioned New River Substation. This will allow the New River Substation to absorb much of the current electric load of another substation, ensuring the continued delivery of safe and reliable power.

Clark County - Energy Efficiency - \$1,000,000

Clark County's Energy Efficiency project request will fund the removal of outdoor metal halide lighting fixtures and replacement with energy efficient LED fixtures in four major areas throughout the county.

<u>Lincoln County Power District - Solar - \$1,750,000</u>

Lincoln County Power District's (LCPD) Solar project request will fund a planned 2 MW, fixed tilt ground mount, solar energy system.

University of Nevada Reno - Lithium Characterization Analysis - \$1,600,000

UNR's Lithium Characterization Analysis project request will fund the establishment of a Lithium Characterization, Analysis, and Testing (Li-CAT) Laboratory to partner with the private sector in providing much needed advanced characterization and data interpretation services.

Financial Services and General Government: (3 total)

City of North Las Vegas - Small Business Connector - \$180,000

City of North Las Vegas' Small Business Connector project request will continue a pilot program launched by the City to provide services to small businesses including advisory sessions, business plan development, permitting and licensing navigation, workshops, and navigation of grant and loan programs.

Clark County - Small Business Opportunity Program (SBOP) - \$350,000

Clark County's Small Business Opportunity Program (SBOP) Upgrade project request will upgrade SBOP to a virtual platform to expand access to small business programming and content.

<u>Lander County Convention & Tourism Authority - Lemaire Building Small Business Incubator -</u> \$1,000,000

Lander County Convention & Tourism Authority's Lemaire Business Incubator project request will fund the first phase of a stabilization and renovation project to restore a historic building for the purposes of providing a small business incubator in a rural community.

Homeland Security: (1 total)

<u>Washoe County – Lemmon Valley Heppner 5 Subdivision Stormwater Improvements -</u> \$2,700,000

Washoe County's Lemmon Valley Heppner 5 Subdivision Stormwater Improvements project request will help design and install a regional detention and sedimentation basin above the Heppner 5 subdivision in Lemmon Valley to provide greater community resilience. The project will upgrade existing water conveyance infrastructure and install a sediment and runoff detention basin to mitigate flooding in the community.

Interior and Environment: (14 total)

Churchill County - Water Storage Tank - \$3,000,000

Churchill County's Water Storage Tank project request will replace open storage ponds with enclosed effluent water storage tanks at the waste water treatment facility. A water storage tank will prevent evaporation in open ponds, thereby further conserving water in the County's arid desert environment.

City of Ely - Lower East Ely Water Mains Upgrade - \$2,430,000

City of Ely's Lower East Ely Water Mains Upgrade project request will upgrade the city's water mains in Lower East Ely. This project is a high priority for the city due to the fact that the water lines provide essential potable water service to residents of the community and the age of the current water lines in this area.

City of Fallon - Wastewater Treatment Plant Dewatering Press - \$4,369,600

City of Fallon's Wastewater Treatment Plant Dewatering Press project request will construct a new dewatering press at the city's Wastewater Treatment Plant (WWTP). This will more effectively process the biosolids generated from the treatment processes at the plant and allow the city to respond to current and anticipated population growth.

City of North Las Vegas - Robinson Well Rehab - \$2,500,000

City of North Las Vegas' Robinson Well Rehab project request will rehabilitate a groundwater production well.

City of Reno - Booth Street Sewer Siphon - \$1,500,000

City of Reno's Booth Street Sewer Siphon project request will replace the aging and undersized Booth Street sewer siphon and approximately 1,100 feet of unreinforced concrete sewer main.

<u>City of Sparks - Truckee Meadows Water Reclamation Facility Disinfection Upgrades -</u> \$800,000

City of Sparks' Truckee Meadows Water Reclamation Facility's Disinfection Upgrades project request will help upgrade the current water disinfection process to eliminate the need for process chemicals, lowering both operation cost and runoff to the Truckee River and Pyramid Lake.

<u>Clark County Water Reclamation District - Logandale Sewer Collection Extension - \$2,000,000</u> Clark County Water Reclamation District's Logandale Sewer Collection Extension project request will install 8,000 feet of wastewater collection infrastructure that will make sewer lines available to residences, businesses, and public entities.

<u>Clark County Water Reclamation District - Water Infrastructure Project - \$2,000,000</u> Clark County Water Reclamation District's Reclaimed Water Infrastructure project request will remove old water lines and install new water lines, meters, and valves.

<u>Incline Village General Improvement District - Effluent Export Pipeline - \$1,600,000</u>
Incline Village General Improvement District's (IVGID) Effluent Export Pipeline project request will replace 5 miles of original effluent export pipeline (EEP) servicing Incline Village and Crystal Bay.

Moapa Valley Water District - Transmission Replacement - \$2,476,640

Moapa Valley Water District's Transmission Replacement project request will replace approximately two (2) miles of a critical length of existing 24-inch potable water transmission line that has experienced a high leak/break rate.

<u>Southern Nevada Water Authority - Southern Nevada Septic Conversion Program - \$3,000,000</u> Southern Nevada Water Authority's Southern Nevada Septic Conversion Program project request will help fund SNWA's Septic Conversion Program, which helps homeowners offset the cost of converting to the municipal sewer system.

<u>Truckee Meadows Water Authority - Spanish Springs Nitrate and Arsenic Treatment Plant - \$3,000,000</u>

Truckee Meadows Water Authority's Spanish Springs Nitrate and Arsenic Treatment Plant project request will design a treatment plant to remove nitrate and arsenic from the wells in the Spanish Springs area.

<u>Virgin Valley Water District - Arsenic Treatment Plan - \$3,040,000</u>

Virgin Valley Water District's Arsenic Treatment Plant project request will construct a new arsenic removal treatment plant to serve the City of Mesquite and the Town of Bunkerville.

<u>Virgin Valley Water District - Waterline Replacement - \$2,660,000</u>

Virgin Valley Water District's Waterline Replacement project request will replace failing water lines at the intersections of Falcon Ridge Parkway and Pioneer Boulevard, and Hillside Drive and Sandhill Boulevard.

Labor, HHS, and Education: (25 total)

<u>City of North Las Vegas – Fire Department Crisis Response Unit - \$875,000</u>

City of North Las Vegas Fire Department's Crisis Response Unit project request will create a Crisis Response Unit staffed by a licensed social worker, a paramedic, and an EMT. The unit will be specially trained to respond to situations involving individuals with mental health or substance abuse issues, ensuring the safety of everyone involved.

<u>Clark County – Expansion of Clark County Social Services Mobile Health Outreach Program – Health Nation - \$1,330,000</u>

Clark County Department of Social Service's Health Nation project request will be used to provide additional equipment and purchase an additional mobile office trailer which will allow for ongoing expansion.

<u>Clark County - Expansion of Project HOPE - \$3,100,000</u>

Clark County Department of Family Services' Expansion of Project HOPE project request will provide victim-centered residential services with high-quality clinical services.

<u>Clark County - Expansion of the Southern Nevada Children's Advocacy Center - \$1,600,000</u> Clark County's Expansion of the Southern Nevada Children's Advocacy Center project request will fund the design and engineering costs associated with the expansion of the center including additional medical clinic and/or mental health treatment rooms in the new Southern Nevada Children's Advocacy Center (SNCAC).

Clark County - Justice System Improvement Project - \$214,000

Clark County's Justice System Improvement project request will provide effective and community-based legal services by having on-site access to necessary technology or accommodations to facilitate participation in judicial proceedings and case management conferences.

<u>Clark County - Las Vegas Metro Diversion (LVMD) Program Expansion - \$1,709,594</u> Clark County's LVMD Program Expansion project request will expand the current Clark County/Las Vegas Metro Diversion Program, which provides mental health and substance abuse support services.

<u>Clark County - Mental Health Services for DJJS Home for Traumatized Girls - \$1,224,000</u> Clark County Department of Juvenile Justice Services' (DJJS) Home for Traumatized Girls project request will fund mental health and substance abuse program support staff to serve girls who have faced trauma and mental health issues.

College of Southern Nevada - Nursing Skills Lab - \$750,000

College of Southern Nevada's Nursing Skills lab project request will fund facilities and equipment for two nursing labs, one at the Charleston site and one at the North Las Vegas site. Both sites need updated skills and simulation lab equipment that will help students train on the latest technologies to meet the growing demand in the region for health care workers.

Great Basin College - Health Science Lab Equipment - \$940,000

Great Basin College's Health Science Lab Equipment project request will fund necessary lab and classroom equipment for two new lab credential classes in fall 2023. Funding will also be used to install Interactive Video (IAV) equipment in two classrooms to facilitate distance instruction; both Medical Assistant/Phlebotomy EKG (MAPE) classrooms also will need to be retrofitted in order to accommodate the labs.

Lander County - Austin Clinic - \$800,000

Lander County's Austin Clinic project request will be used for capital improvements to the community health clinic.

<u>Lincoln County Hospital District - Grover C. Dils Medical Center Replacement Hospital -</u> \$3,000,000

Lincoln County's Grover C. Dils Medical Center Replacement Hospital project request will fund a replacement hospital located in rural Caliente, NV.

<u>Lyon County Human Services - Community Based Mentoring - \$119,000</u>

Lyon County's Community Based Mentoring project request will help create a mentoring system for at-risk youth. Funds will be used to recruit, screen, and train adult mentors, and conduct surveys to track the outcomes of enrolled kids.

<u>Nevada State College – Mental Health Clinic - \$1,337,000</u>

Nevada State College's Mental Health Clinic project request will establish a comprehensive evaluation clinic. The Clinic will provide mental health services for Clark County School District PK-12 students and their families. The clinic will also serve as a training facility for students at Nevada State College who are preparing to become school psychologists.

Nevada State College - Nurse Educator Faculty Recruitment - \$1,776,000

Nevada State College's Nurse Educator Faculty Recruitment project request will create a pilot project to cultivate an innovative and holistic professional development support structure for new and existing nursing faculty at Nevada State College. The implementation of this project plan will improve the nursing pipeline by strengthening the nurse educator workforce resulting in positive outcomes for healthcare consumers in Nevada.

Nevada State College - Nursing Night Education Program - \$1,685,000

Nevada State College's Nursing Night Education Program project request will create a prelicensure evening/night full-time track cohort to improve the professional nursing pipeline and accommodate the diverse, non-traditional students served by NSC.

Nye County School District - Work-Based Learning - \$152,000

Nye County School District's Work-Based Learning project request will support students that are not eligible for the Workforce Innovative and Opportunity Act (WIOA) Youth Program but still have needs identified by teachers, probation officers, school staff, district staff, and community stakeholders. Through this program, the district will establish partnerships with businesses in Nye communities that host high school students, building the bonds in each community.

Southern Nevada Workforce Connections - Development Program - \$800,000

Workforce Connections' Development Program project request will launch regional sector partnerships for industries that face critical workforce talent/skill gap needs. These partnerships will help support businesses, communities and overall regional economic growth.

<u>University of Nevada, Las Vegas - Functional MRI Scanner for Biomedical Research -</u> \$4,515,000

UNLV's Functional MRI Scanner for Biomedical Research project request will fund a functional MRI (fMRI) scanner to campus that will improve research capacity at the University. The fMRI will provide an opportunity for scanning capabilities for students in the UNLV School of Medicine and serve as a clinical resource for many UNLV initiatives that will engage with the surrounding community.

University of Nevada, Las Vegas - Sports Research and Innovation - \$3,250,000

UNLV's Sports Research and Innovation project request will fund a High-Performance Computer (HPC) and related curriculum coordination to expand the University's capacity for advanced research and education. UNLV's request for a HPC will allow for a central hub for researchers and students to conduct data analytics and disseminate data to various user groups

University of Nevada, Reno – Air Contaminants Cleanroom - \$3,000,000

UNR's Air Contaminants Cleanroom project request will create a cleanroom facility and provide initial support for technical and management personnel that will enable UNR's entry into many new lines of research. A cleanroom facility center reduces air contaminants from typical levels and will provide an ultra-clean environment for teaching, research and manufacturing.

<u>University of Nevada Reno - Women in STEM: Aligning Closure of Academic Gender Gap in Sciences with Nevada Workforce Needs - \$400,000</u>

UNR's Women in STEM project request will partner with Complete College America to close gender gaps in Science, Technology, Engineering, and Mathematics (STEM) fields. Funding will be used to increase STEM field outreach, pre-enrollment activities, and increase women in STEM fields, including at certificate, associate, and baccalaureate levels.

Washoe County School District - Direct Mental Health Support for Students - \$1,535,000

Washoe County School District's Direct Mental Health Support for Students project request will add 11 Mental Health Professionals to the district to provide greater therapeutic support to students, giving them immediate help during a crisis.

Washoe County - Northern Nevada HOPES Cares Campus Clinic - \$2,000,000

Washoe County's Northern Nevada HOPES Cares Campus Clinic project request will support HOPES in constructing a new Federally Qualified Health Center on East 4th Street in Reno, Nevada. The facility is located directly adjacent to the Washoe County Cares Campus; the County-operated homeless shelter.

Washoe County School District - Chronic Absenteeism - \$1,024,000

Washoe County School District's Chronic Absenteeism project request will expand school-based student support staff and increase the number of Family Resource Centers available in Washoe County.

Western Nevada College - Rural Nursing Expansion and Renovation Project - \$2,314,000

Western Nevada College's Rural Nursing Expansion and Renovation project request will create a permanent instructional training space for its rural nursing cohort at the Fallon Campus (health facilities, construction, and equipment).

Military Construction and Veteran Affairs: (1 total)

Nellis Air Force Base – Dormitory - \$7,200,000

Nellis AFB Dormitory project request will fund project and development (P&D) design of a 240-room dormitory at Nellis Air Force Base to enable future year's appropriations for construction. Additional housing will address a housing shortage for junior enlisted Airmen on Nellis AFB.

Transportation, Housing, and Urban Development: (22 total)

<u>Carson City Public Works - Appion Way Traffic Signal and Infrastructure Improvement -</u> \$1,100,000

Carson City's Appion Way Traffic Signal and Infrastructure Improvement project request will help construct a new traffic signal and fund traffic circulation improvements at the intersection of S. Carson Street and Appion Way in Carson City.

City of North Las Vegas - Small Business Forgivable Loan Program - \$750,000

City of North Las Vegas'Small Business Forgivable Loan Program project request will recapitalize the City's existing Small Business Forgivable Loan Program, which provides loans to small businesses, prioritizing low-income communities, minority, and women-owned businesses.

<u>City of North Las Vegas - Urban Center for Advanced Agricultural Technologies - \$1,500,000</u> City of North Las Vegas' Urban Center for Advanced Agricultural Technologies' project request will expand this facility through the renovation of the commercial demonstration kitchen, expansion of education spaces, installation of new utilities, and other facility upgrades.

City of Reno - Rooftop Solar at the Moana Aquatics & Fitness Center - \$800,000

City of Reno's Rooftop Solar at the Moana Aquatics & Fitness Center project request will help fund the addition of rooftop solar at the proposed Moana Aquatics & Fitness Center. The City is in the design stages for this proposed two-level facility open to the public.

Clark County - Jewish Family Services Agency - CDBG Tenant Improvement - \$2,555,000

Clark County's Jewish Family Services Agency CDBG Tenant Improvements project request will be used by the County to renovate and complete a newly purchased building for the Jewish Family Services Agency (JFSA) building. The JFSA provides food, senior services, rapid rehousing/basic needs to all members of the community.

<u>Clark County Department of Aviation - Overton Field Reconstruction (Perkins Field (U08) - Reconstruction of Runway, Taxiway, and Apron) - \$8,437,000</u>

Clark County Department of Aviation's Overton Airfield Reconstruction project request will help fund reconstruction of the runway, taxiway, and apron at Overton Perkins Field and weather reporting equipment. The quality of the current pavement areas of the runway and apron are poor and this project will also ensure compliance with FAA Design Standards.

Douglas County - Kahle Drive Complete Street Project - \$1,385,000

Douglas County's Kahle Drive Complete Street project request will help re-construction of Kahle Drive. This will include improving stormwater drainage and treatment; upgrading an outdated water main and hydrants; repairing wastewater infrastructure; adding sidewalks, bike lanes, crosswalks, and intersection safety improvements; and undergrounding overhead utilities.

Lander County - Community Center - \$638,000

Lander County's Community Center project request will support an educational and community development anchor for downtown Austin. Once completed, the center will provide programs and services targeting senior citizens and underserved communities.

Nevada Department of Transportation - 215/515 Henderson Interchange - \$5,000,000

Nevada Department of Transportation's 215/515 Henderson Interchange Traffic Improvement project request will improve traffic operations at the I-515 and I-11 interchange. The project will resolve existing roadway deficiencies in the Henderson Interchange and surrounding roadways, provide transportation improvements to serve existing and future growth areas, and restore local traffic connectivity.

<u>Nevada Department of Transportation - Churchill County Moody Lane/Coleman Road</u> <u>Connector Construction - \$4,000,000</u>

Churchill County's Coleman Road Connector project request will provide an alternate route for traffic traveling from rural areas north of Fallon into the central retail/commercial area of Fallon. This project will increase access to local businesses and educational institutions and accommodate the expected growth in population to the area.

<u>Nevada Department of Transportation - City of Las Vegas Next Generation Signal Prioritization</u> - \$3,000,000

City of Las Vegas' Next Generation Signal Prioritization project request will support upgrading the City's current communications devices with a cloud-based signal prioritization software. This will provide signal prioritization and preemption technology for emergency responders, allowing them to reach the scene up to 50% faster.

<u>Nevada Department of Transportation - Clark County Pedestrian Flashers and Safety</u> <u>Improvements - \$3,000,000</u>

Clark County's Pedestrian Flashers and Safety Improvements project request will provide improvements to pedestrian safety and enhance accessibility including the construction of pedestrian flashers at crossings.

<u>Nevada Department of Transportation - Ely Downtown Infrastructure and Complete Streets -</u> \$5,000,000

Nevada Department of Transportation's Ely Downtown Infrastructure and Complete Streets project request will support Phase 2 of the Downtown Ely Project through full depth pavement rehabilitation, including replacement/widening of sidewalks and drainage improvements. This will replace aging infrastructure and improve safety for all roadway users, focusing on vulnerable road users by providing improved bicycle and pedestrian features.

<u>Nevada Department of Transportation - Regional Transportation Commission of Washoe County</u> (RTC Washoe) Lemmon Drive Reconstruction - \$4,000,000

RTC Washoe's Lemmon Drive Segment Two (2) Improvement project request will help reconstruct 3.7 miles of Lemmon Drive between Fleetwood Drive to Ramsey Way above the 100-year flood plain of Swan Lake. This will improve safety in the area's Historically Disadvantaged Communities, construct dedicated bike lanes and a separated multi-use path, and widen Lemmon Drive from Fleetwood Drive to Palace Drive.

<u>Nye County – Tonopah Child Development Center - \$1,000,000</u>

Nye County's Tonopah Child Development Center project request will design and build a new Child Development Center to serve children and families in and around the community. Tonopah currently has no licensed childcare providers. The proposed Child Development Center is part of the Town's efforts to prevent social problems, help the community get to work, support local business' needs, and increase recruitment and retention efforts of critical service professionals in the area.

<u>Pyramid Lake Paiute Tribe - Food Distribution Program - \$598,000</u>

Pyramid Lake Paiute Tribe's Food Distribution Program project request will help purchase and install materials to complete the interior walls of the 22,500 square foot food distribution warehouse. The Pyramid Lake Paiute Tribe's Food Distribution Program opened on April 4, 2022, and currently serves over 200 participants, benefitting both Tribal and non-Tribal members.

<u>Regional Transportation Commission of Southern Nevada (RTCSNV) - Pedestrian Collision</u> <u>Avoidance System - \$3,575,200</u>

RTCSNV's Pedestrian Collision Avoidance System project request will provide real-time alerts for transit bus operators to react and avoid collisions. This will improve safety for pedestrians, cyclists, and transit riders.

<u>Regional Transportation Commission of Southern Nevada (RTCSNV) - Standalone Solar</u> <u>Lighting for 500 Transit Stops - \$1,960,000</u>

RTCSNV's Standalone Solar Lighting for 500 Transit Stops project request will provide for the installation of standalone solar lighting at an additional 500 bus stops throughout the RTCSNV service area.

<u>Regional Transportation Commission of Washoe County (RTC Washoe) - Villanova</u> Maintenance Facility Replacement Design - \$3,000,000

RTC Washoe's Villanova Maintenance Facility Replacement Design project request will include architectural and engineering work necessary to support the eventual relocation and replacement of RTC Washoe's primary transit facility. When finished, this facility will lower RTC Washoe's operating expenses, add improvements for sustainability, and provide investment and economic development in a disadvantaged area.

<u>Reno-Tahoe Airport Authority – Reno Airport (RNO) Terminal Road Improvements - \$3,589,000</u> Reno-Tahoe Airport Authority's RNO Terminal Roadway Construction, Safety & Security, and ADA Improvements project request will install and construct critical improvements along Terminal Loop Road, which also serves as passenger pick-up and drop-off areas.

Storey County - Lockwood Senior Center - \$2,500,000

Storey County's Lockwood Senior Center project request will replace the existing outdated and inadequate senior center facility. With a new commercial kitchen, Lockwood Senior Center will be able to prepare food onsite for the community and for the neighboring elementary school which currently does not provide school lunches.

<u>Tahoe Transportation District - Transit Maintenance and Administration Facility - \$2,000,000</u> Tahoe Transportation District's Transit Maintenance and Administration Facility project request will help construct a new Maintenance and Administrative Facility (MAF) to replace the existing, inadequate, and outdated transit yard in order to provide ongoing fleet maintenance, allow for efficient bus-related administrative activities, and afford adequate storage for the existing fleet.
