**A BILL**

To amend the National Defense Authorization Act for Fiscal Year 2000 to extend and modify requirements for an annual report on military and security developments involving the People’s Republic of China.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “China Military Power  
5       Transparency Act of 2025”.

1 **SEC. 2. EXTENSION AND MODIFICATION OF ANNUAL RE-**  
2 **PORT ON MILITARY AND SECURITY DEVELOP-**  
3 **MENTS INVOLVING THE PEOPLE'S REPUBLIC**  
4 **OF CHINA.**

5 (a) EXTENSION.—Subsection (a) of section 1202 of  
6 the National Defense Authorization Act for Fiscal Year  
7 2000 (10 U.S.C. 113 note) is amended by striking “Janu-  
8 ary 31, 2027” and inserting “January 31, 2030”.

9 (b) MATTERS TO BE INCLUDED.—Subsection (b) of  
10 such section is amended—

11 (1) in paragraph (3)(C), by striking the period  
12 at the end and inserting “, including nuclear and  
13 drone development cooperation.”;

14 (2) in paragraph (7)(A), by inserting “, includ-  
15 ing foreign farmland acquisitions,” after “Chinese  
16 overseas investments or projects”;

17 (3) in paragraph (8)(A)—

18 (A) by striking “infrastructure) and” and  
19 inserting “infrastructure),”; and

20 (B) by striking the period at the end and  
21 inserting “, and the likely role of Chinese cyber  
22 capabilities in a conflict with the United  
23 States.”;

24 (4) in paragraph (9)(B), by striking “and other  
25 advanced technologies” and inserting “biotechnology,  
26 and other advanced and emerging technologies”; and

1 (5) in paragraph (10)—

2 (A) in subparagraph (A), by striking  
3 “and” at the end;

4 (B) by redesignating subparagraph (B) as  
5 subparagraph (C); and

6 (C) by inserting after subparagraph (A)  
7 the following new subparagraph (B):

8 “(B) the likely strategic intent of the Peo-  
9 ple’s Liberation Army in a conflict over Taiwan,  
10 and how the People’s Republic of China will  
11 conduct a cyber enabled economic warfare cam-  
12 paign, a cross straight invasion campaign, or a  
13 blockade campaign; and”.
